

Fund Update

***Note:** On 24 July 2026, the scheme name changed to Hive KiwiSaver Scheme and the fund name changed to Hive Aurora Conservative Fund. Both name changes will be reflected in future fund updates.

What is the purpose of this update?

This document tells you how the Aurora Conservative Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Hive Funds Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

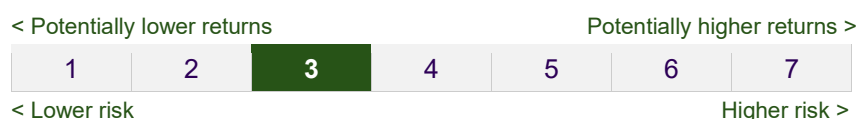
Objective: To deliver returns exceeding the CPI by 2.5% per annum before fees and tax, over a suggested investment timeframe of 3 to 5 years.

Strategy: A multi-asset class fund that is diversified across asset classes and underlying investment managers. It has exposure primarily to fixed interest securities and a smaller exposure to equities and other growth assets.

What are the risks of investing?

Risk indicator for the Aurora Conservative Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

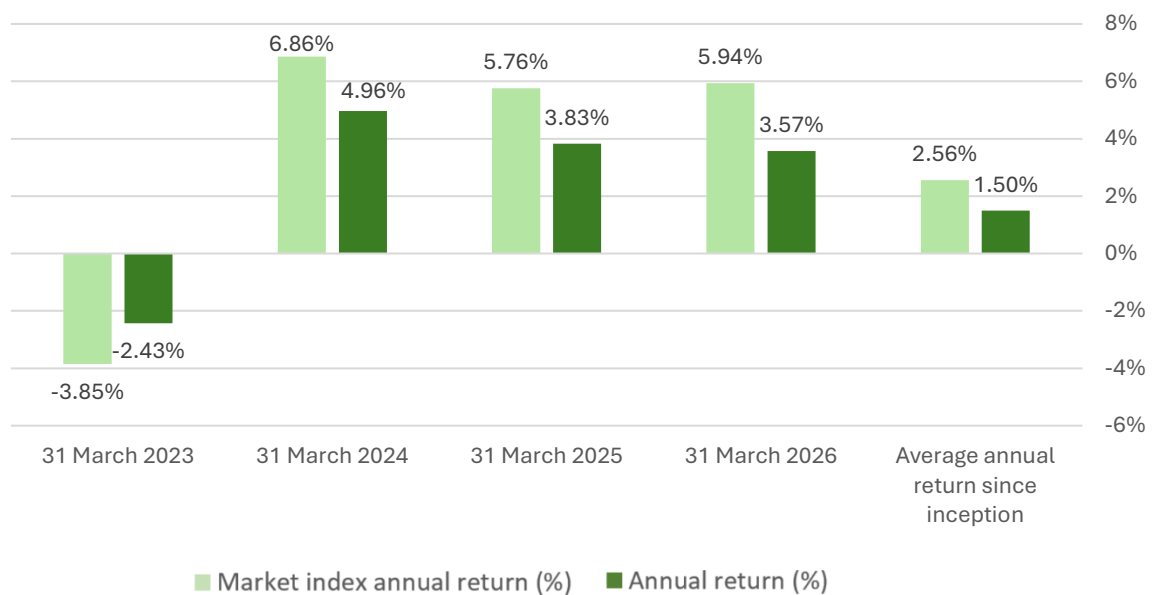

How has the fund performed?

The market index return is a composite of benchmark index returns, weighted to reflect the fund's target asset allocation. The benchmark index used for each asset class is defined in the Statement of Investment Policy and Objectives (**SIPO**). Annual Return Graph



This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 30 June 2026.

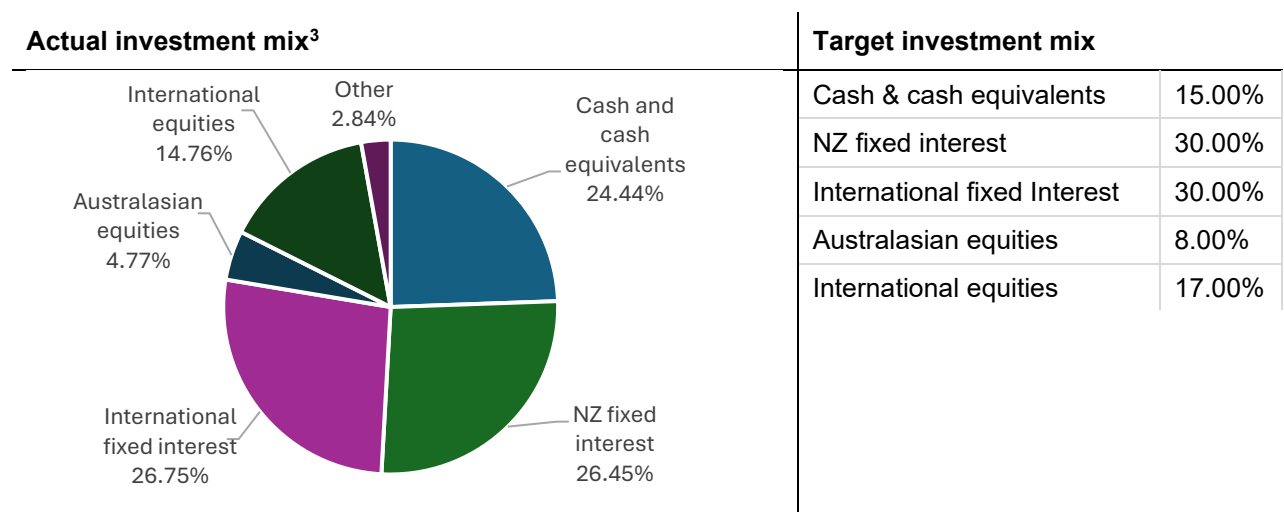
Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$512 (that is 5.12% of his initial \$10,000). Anthony also paid \$36 in other charges. This gives Anthony a return after tax of \$437 for the year.

What does the fund invest in?

Notes

¹ As this fund has existed for less than 5 years, the risk indicator is calculated for a 5-year period using a combination of market index returns (1 July 2021 – 31 August 2021) and actual returns (1 September 2021 – 30 June 2026). The risk indicator may therefore provide a less reliable indication of the investment options' future volatility.

² **"Other management and administration charges"** includes estimates of certain charges incurred in the underlying funds in which the fund invests. The estimates incorporate information provided by underlying fund managers as well as information sourced from the underlying fund's disclosure documents.

³ **"Other"** includes forward currency contracts and unitised investments with a mix of various asset classes (NZ fixed interest and international fixed interest).
